Booking and Payment

Once you have selected the course you wish to attend, please contact training@ltsc.co.uk to check availability. A deposit of 50% of the total course fee is required to confirm the booking. The balance of the course fee is due one month prior to the course date. For booking made within one month, payment in full will be required.

LTSC accepts, cash, cheques and all major credit and debit cards. Cheques should be made payable to Lymington Town Sailing Club. Online booking via the LTSC website is available.

Receipts of payments should be kept in the event of a query.

A signed booking form is required by all course candidates. Parents/Guardians of candidates Under 18's must sign the booking form.

Cancellation or Transfer by Lymington Town Sailing Club

Lymington Town Sailing Club reserves the right to:

- Postpone a course should the numbers fail to reach a viable minimum. If these dates are not acceptable to the candidate then a full refund will be offered.
- Request a participant who does not meet the course criteria to withdraw.
- Decline to award a certificate (but will give reasons and an action plan).
- If due to forecast or prevailing weather conditions, or due to factors out of our control we have the right to cancel a booking, then alternative mutually suitable dates will be arranged.

Personal Insurance

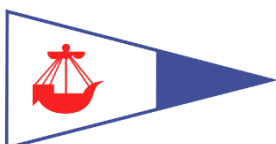
LTSC accepts no responsibility against personal loss, damage, injury or accident whilst participating in any activity.

Watersports can be physically demanding and may involve bending, lifting, balancing, jumping, climbing, stretching, and demand a degree of co-ordination. You must ensure that you have an adequate level of fitness for the activities undertaken. If you have any medical condition or illness you must inform us when you make your booking. LTSC accepts no responsibility for any client's medical condition, or accident stemming directly or indirectly from it. All medical conditions must be noted on the medical form. All participants must comply with instructions and directions of staff at all times.
